Fact Sheet

SCHOLARSHIPS:

Dakota Plains Federal Credit Union will award one **\$500** scholarship from **each** of its 5 branches to eligible applicants. These scholarships are awarded to applicants who exemplify the credit union philosophy of “people helping people” through volunteerism, community service and leadership.

ELIGIBILITY REQUIREMENTS:

To be eligible for consideration, the applicant must meet the following criteria:

- 1) Be a United States citizen.
- 2) **Be a DPFCU member with active accounts.**
- 3) Be a graduating high school senior.
- 4) Be planning to attend a 2 or a 4-year post-secondary, accredited undergraduate degree program or a technical/vocational school.
- 5) Must present letter of acceptance from the college/technical/vocational school.

APPLICATION REQUIREMENTS:

- 1) A completed **DPFCU Scholarship Application** form (no substitute forms please) including:
 - a. Copy of your official transcript and copy of your current ACT/SAT score(s).
 - b. Listing of volunteer work/job experiences
 - c. Listing of extracurricular activities/organizations
 - d. Listing of accomplishments, honors, awards received
- 2) A written recommendation/character reference letter for the applicant must accompany the application. Such letter(s) may be from teachers, counselor, community leader, religious leader, or work supervisor.
- 3) An essay, between 300-400 words on the subject of: **“How, through your involvement in community/school activities or events or volunteer efforts, have you shown the cooperative spirit?”**

JUDGING CRITERIA:

The Judging Committee shall consist of credit union volunteers or employees from various branches and will score each requirement on the following categories:

- 1) Academic.
- 2) Volunteer work/job experience.
- 3) Extracurricular activities/organizations.
- 4) Accomplishments, honors, and awards.
- 5) Overall appearance, content, grammar and neatness of application and essay.

APPLICATION DEADLINE:

Applications must be postmarked by **FRIDAY APRIL 5, 2024**. Applications should be sent to the following address:
